


BYLAW NO. 01/2004


**A BYLAW OF THE RURAL MUNICIPALITY OF SHERWOOD NO. 159
TO PROVIDE FOR THE LICENSING OF OPERATORS OF MOBILE HOME PARKS OR
COURTS, TRAILER PARKS OR COURTS PURSUANT TO CLAUSE 213 (1) (E) OF THE
RURAL MUNICIPALITY ACT, 1989**

The Council of the Rural Municipality of Sherwood No. 159, in the Province of Saskatchewan enacts as follows:

1. No person shall operate a mobile home park or court, trailer park or court within the boundaries of the municipality without *first* obtaining a license from Administration.
2. The license fee shall be payable in advance and shall expire on December 31 next following the date of issue. Upon receipt of the fee a General Receipt from the municipality will be issued; this receipt shall represent the License for the operation of a Mobile Home Park or court, trailer park or court for that year.
3. The license fee shall be ONE HUNDRED DOLLARS.
4. The operator of a mobile home park or court, trailer park or court licensed under this bylaw is hereby authorized and required to collect from the occupant of any Mobile homes, trailer coaches, trailers or portable shack situated within the confines of the mobile home park or court, trailer park or court such license fee as is required to be paid by such occupant under a bylaw of the municipality, unless the said occupant produces a valid license for inspection.
5. All fees collected under Section 4 of this bylaw shall be turned over to the administrator of the municipality within five days after the end of the month in which they are collected.
6. It shall be the responsibility of the operator of a mobile home park or court, trailer park or court licensed under this bylaw to register each mobile home, trailer coach, trailer or portable shack located therein in a proper record maintained for that purpose showing the name of the occupant, date of departure and the number of any valid license held by the occupant issued under a bylaw of the municipality. Any fees collected under Section 4 of this bylaw shall also be recorded opposite the name of the registered occupant, together with the date of collection.
7. The record mentioned in Section 6 shall be open to inspection at all times to the license inspector of the municipality.
8. Sections 4 to 7 and Section 9 of this bylaw shall apply mutatis mutandis to every owner or occupant of property who permits two or more mobile homes, trailer coach's, trailers or portable shacks to be located thereon.
9. A person who contravenes any of the provisions of this bylaw is **guilty of an offence** and liable on summary conviction to the penalties provided under Section 174(5)(b) of the R.M. Act.
10. Bylaw No. 6/92 passed on the 9th day of September 1992 is hereby repealed.
