BYLAW NO. 3/00

A BYLAW TO REGULATE THE RUNNING AT LARGE OF ANIMALS

The Council of the Municipality of Sherwood in the province of Saskatchewan enacts as follows:

- For the purpose of this bylaw the expressions:
 - (a) "Dog" shall mean either male or female.
 - (b) "Municipality" shall mean the Rural Municipality of Sherwood.
 - (c) "Running at large" shall mean that the dog is beyond the boundaries of the land occupied by the owner, possessor, or harbourer of the said dog, or beyond the boundaries of any lands where it may be with the permission of the owner or occupant of the said land and when it is not under control by being;
 - (i) securely confined within an enclosure; or
 - (ii) securely fastened so that it cannot roam at will.
- 2. No dog shall run at large in the municipality.
- A person who owns, possesses, or harbors a dog that is found running at large shall be deemed guilty of an infraction of this bylaw.
- A dog running at large may be impounded at the Regina Humane Society at which time the handling of the dog will fall under the rules and regulations of the Regina Human Society.
- 5. A person who contravenes any of the provisions of Sections 2 or 3 of this bylaw, shall be guilty of an offence and upon convictions, shall be liable to a penalty of:

1st offence - warning 2nd offence - \$25.00

3rd offence -\$50.00

- A violator of this bylaw, upon being served with a Notice of Violation, may voluntarily pay the penalty at the Municipal Office, and upon payment as so provided, that person shall not be liable to prosecution of the offence.
- The Notice of Violation shall be Appendix "A", attached to and forming part of this bylaw, or an
 equivalent, issued by a Peace Officer pursuant to the Summary Offences Procedure Act, 1990.
