



**BYLAW NO. 07/01**  
**REFUSE DISPOSAL & BURNING BYLAW**  
**OF THE RURAL MUNICIPALITY OF SHERWOOD NO. 159**


The Council of the Rural Municipality of Sherwood No. 159 in the Province of Saskatchewan hereby enacts as follows:

1. Pursuant to **S. 168.1 of the Rural Municipality Act, 1989** no person shall bring refuse to be disposed of, into the R.M. of Sherwood No. 159. This section does not apply to recyclable products brought into the R.M. for recycling.
2. Any person burning refuse which has been generated on site, shall give notice to the City of Regina Fire Department, R.M. of Sherwood and RCMP prior to burning and shall be liable for any charges levied pursuant to the City of Regina / Sherwood fire agreement.
3. All terms and expressions used in sections 5 & 6 of this bylaw shall have the same respective meanings as in Section 2 and 18 of **The Clean Air Act** and Section 11 of **The Clean Air Regulations**.
4. Within areas zoned commercial and industrial pursuant to the **Sherwood Regina District Zoning Bylaw 10-91**, no person shall burn, or cause to have burned, refuse without first obtaining an open air fire permit Schedule A, from the R.M. of Sherwood.
5. Exclusions: Sections 3 & 4 of this bylaw do not apply to:
  - a) A camp fire or outdoor fireplace used for recreational purposes.
  - b) An outdoor fire using charcoal, processed coal or coke for cooking purposes.

**Applicant, Please Note:**

- It is the responsibility of the applicant to notify the Fire Department before burning
- Measures which can be considered to limit fire spread include sufficient clear space between the fire and adjacent buildings, combustibles, the size and height of combustibles to be burned, the prevailing meteorological conditions, fire control measures such as extinguishers, hoses and water tanks and the design of the receptacle.
- It is the applicant's responsibility to ensure that smoke, fumes or other matter does not cause a nuisance to others.
- Burning of any materials which may be hazardous requires that the applicant obtain approval from Saskatchewan Environment and Resource Management.
