### Discounts Available

The following discounts will be applied if payment is received:

By August 31<sup>st</sup> 5%
By September 30<sup>th</sup> 4%
By October 31<sup>st</sup> 3%
By November 30<sup>th</sup> 2%

Please note that the discount does not apply to Education Property Taxes.

Payments are processed and the applicable discount applied according to the date payment is received.

Agricultural	1.404
Residential	0.969
Commercial/Industrial-Other	0.94

Municipal taxes are calculated as follows:

Taxable Assessment x Mill Rate x Mill Rate Factor ÷ 1000

Paving one mile of Inland Drive

(\$2.8 Million)

Gravel/Sand/Salt

(\$1.25 Million)

New Municipal Office Construction

(\$1.2 Million)

**Equipment Purchases** 

(\$534,500)

Capital Reserve Fund Contribution Bridge Repair/Replacement

(\$300,000)

Funding Sources for these projects vary.

The 2015 budgeted Municipal Levy is \$4,453,648.00


