Proposed statement..... I assume you are satisfied with this.

I have been asked by the group to make a presentation regarding the issue you are about to decide in respect to whether or not the decision of Madam Justice Gunn should be appealed to the Court of Appeal of Saskatchewan. Our group makes these requests to you.

Firstly, we urge Council to make as much of its decision and reasoning as possible in open session to ensure that transparency is brought to this issue.

We ask that in your consideration of this issue and the final vote of whether to appeal, the rules as to conflict of interest be applied and followed stringently under the circumstances. We ask all members of council to be honest in assessing whether they should be taking part in the deliberations and also voting on the final decision.

Our group requests that no appeal should be made. We have been advised by our legal counsel that the decision appears to be well reasoned in light of the facts presented to Madam Justice Gunn. There is no reason to seek further clarification and we believe her decision is correct.

Our municipality is in the public spotlight because of recent events. We urge you to consider all of these points carefully and urge you to make a wise decision.
