**BYLAW NO. 02/23**

A Bylaw to amend the RM of Sherwood Zoning Bylaw No. 18/17

The Council of the Rural Municipality of Sherwood No. 159, in the Province of Saskatchewan enacts:

**To amend Bylaw No. 18/17 as follows:**

- (1) To amend The RM of Sherwood Zoning Map by rezoning from Agricultural District (AG) to Rural Residential (RR) for future Parcels B, C, and the Remainder, within LSD 14 Sec. 36-18-21-W2 as shown on the attached Map marked as Schedule A which forms part of this bylaw.
- (2) That this Bylaw shall take effect on the date it is approved by the Minister of Government Relations.

Read a first time on the 22<sup>nd</sup> day of March, 2023.

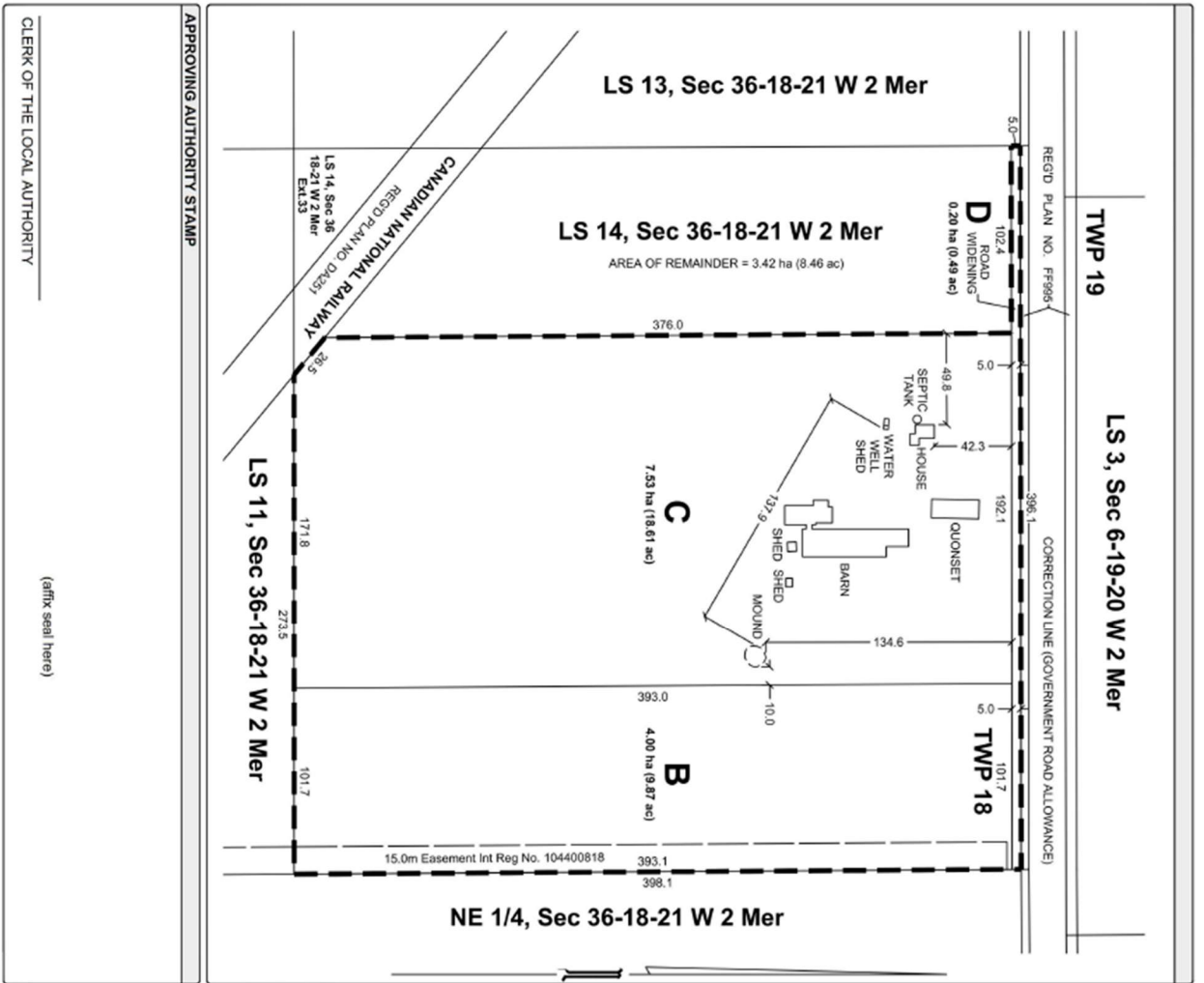
